Subject: Submission of Fresh Pension Cases through Online Diary Management System (ODMS).

Sir/Madam,

Kindly refer to this Department's memo No. 2/2/2019-1Pension (FD) dated 08.02.2021 & 08.07.2021 wherein it was decided by the State Government that a pilot may be conducted in the four (4) districts for submission of Fresh Pension Cases in Online Diary Management System (ODMS) for speedy finalization of pension cases of Government employees. Further it was also decided that during the pilot run the fresh cases may be submitted both through Online Diary Management System (ODMS) as well as in physical form.

Later on, State Government, vide Memo No. 2/2/2019-1Pension (FD) dated 13.06.2022, has extend the pilot run in four (4) more districts, in Haryana for submission of Fresh Pension Cases of Government employees to the Accountant General (A&E) Haryana, Chandigarh both through Online Diary Management System (ODMS) as well as in physical form. The detail of existing eight (8) districts is as under:-

Accountant General (A&E) Haryana and Director General, Treasuries and Accounts Department, Haryana, has now requested to extend the above project across the State for submission of Fresh Pension Cases through Online Diary Management System (ODMS).

After due consideration, State Government has decided to implement the above project across the State for submission of Fresh Pension Cases of the Government employees to Accountant General (A&E) Haryana, Chandigarh through **Online Diary Management System (ODMS)** with effect from **01 January, 2023**.

However, after implementing the above Online Diary Management System (ODMS), the fresh pension cases of Government employees in **physical form, shall not be accepted by Accountant General (A&E), Haryana after 01 January, 2023**.

It is, therefore, requested to direct the concerned officers to comply with the above instructions and send the Fresh Pension Cases of Government employees to the Accountant General (A&E) Haryana Chandigarh through Online Diary Management System (ODMS) only.

Further, the Parivar Pehchan Patra ID (PPP) of the pensioner or Aadhar of the pensioner, in case the pensioner doesn't have PPP ID, should be filled in Online Diary Management System (ODMS).







It is also requested to direct the concerned officer(s) of their office for compliance on the following points:-

- (i) the Online Diary Management System (ODMS) should be integrated with Parivar Pehchan Patra (PPP). Further, the Parivar Pehchan Patra ID (PPP) of the pensioner or Aadhar of the pensioner, in case the pensioner doesn't have PPP ID, should be added as a field in Online Diary Management System (ODMS)
- (ii) to explore to use the data / service of HRMS by integration of ODMS with HRMS or through API so that data be auto populated without manual intervention, as already requested by State Government vide letter No. 2/2/2019-1Pension (FD) dated **13.06.2022**.
- (iii) ODMS dashboard be also provided by their office to Pension Disbursement Cell and Director General, Treasuries & Accounts Department, Haryana to review the progress.
