2 It has been observed by the O/o Principal Accountant General (A&E), Haryana vide Letter No. AMG-II/FIN/2022-23/AP28/AM dated 08.12.2022(copy enclosed) that 912 AC Bills amounting to Rs. 434.35 Crore are yet to be adjusted by Departments which is a serious lapse on the part of Departments. Finance Department has viewed the non-adjustment of AC bills by departments very seriously.

It is, therefore, requested that necessary action on the Detailed Contingent Bills in relation to Abstract Contingency Bills relating to your Department may be initiated immediately and a report in this regard be sent urgently to Principal Accountant General (A&E), Haryana under intimation to Budget and Committee Branch, Finance Department latest by 31st January 2023. Subject:- Entry Conference- Outstanding Abstract Contingency(AC) Bills.

I am directed to convey you that an Entry Conference was held on 31.05.2021 with Principal Accountant General (A&E) Haryana on Scrutiny of Budget 2020-21 & requirement for preparation of Annual Finance and Appropriation Accounts for the Financial Year 2020-21. During this Entry Conference while discussing various points, Principal Accountant General (A&E), Haryana appraised Govt. that as on 31st March 2021, 784 AC Bills involving Rs. 847.25 crores are outstanding. As per details provided by Principal Accountant General (A&E), Haryana following outstanding AC Bills are pending:-

Year	Number of AC Bills	Amount (Rs. in Crore)
Up to 2018-19	85	8.43
2019-20	134	214.05
2020-21	515	624.77

Principal Accountant General (A&E) Haryana further conveyed that non submission of Detailed Contingency (DC) Bills on time entails breach of financial discipline and leads to risk of misappropriation. It has further been requested to State Govt. to obtain DC Bills through Special drive by appointing Nodal Officers in various departments.

In this regard, after due consideration, it has been decided that 85 outstanding AC Bills up to years 2018-19 should be cleared by the concerned Departments by the end of the July 2021. It has further been decided that if any DDO fails to submit DC Bills, then his or her salary will be stopped for the month of July paid in August. Further from now onward, if any AC Bill remains outstanding beyond six months, then the salary of such DDO will be stopped in IFMS. However if any DDO is unable to submit DC Bill within stipulated time, then he will seek exemption from Finance Department, Haryana. All HODs are also requested to appoint a Nodal Officer to monitor and submission of DC bill before due date. List of the pending AC Bills may be downloaded from the website: www.finhry.gov.in

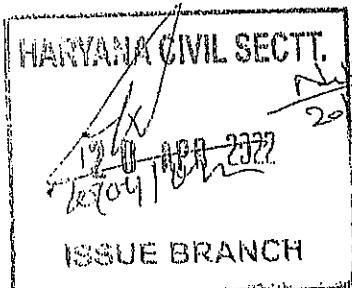

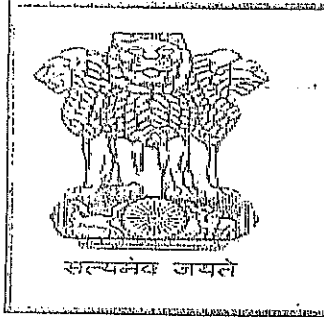

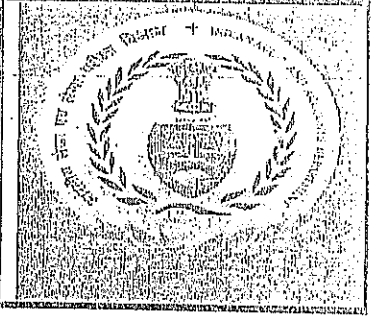

During the test check of records of the O/o the Additional Chief Secretary Finance Department Haryana for the period 2021-22, it has been noticed that the 912 AC bills amounting to Rs. 484.85 crore were pending for Detailed Contingency bill up to August 2022, out of which some bills are pending since January 2016. The detail of AC bill is as under:-

Non submission of DC bills on time entails breach of financial discipline and can lead to risk of misappropriation.

Pendency of AC bills for detailed bills for more than prescribed period shows that the compliance of the above mentioned orders have not been adhered to by the concerned department.
