Improving further the pay structure of Manual Assistant- CWP No. 12943 of 2017 titled as Kiran Bala&ors. Vs. State of Haryana.

Certain Manual Assistants of Food & Civi Supplies Department (in Legal Metrology Organisation) have filed CWP No. 12943 of 2017 titled as Kiran Bala & ors. Vs. State of Haryana in the Hon'ble Punjab and Haryana High Court, Chandigarh with a prayer to modify the pay scale from FPL-1(GP1800) to FPL-2 (GP1900), being Group 'C' post.

The Hon'ble Punjab and Haryana High Court, Chandigarh disposed of the said Civil Writ Petition on 31.08.2022. The operative part of the orders are as under:-

"xxxxxxxxx The competent authority to pass appropriate orders in view of the stand taken in the return and in case, petitioners are found entitled to increase of grade pay xxxxxxxxx."

Accordingly, the matter has been considered by the Government at length. After careful consideration, it has been decided to **further modify the pay structure of Manual Assistant prospectively** in exercise of the powers vested under the provision of Rule-17 of Haryana Civil Services (Revised Pay) Rules, 2016 and all other powers enabling the Government so to do, in the following manner:

The above modification shall be effective prospectively i.e. from the date of issuance of these orders. The pay of the incumbents will be fixed as per previsions contained in Rule-27 of HCS (Payl Rules, 2016.
