No. 1/25/2021-4FD-III — The Governor of Haryana is pleased to reconstitute Natural Resource Accounting (NRA) Cell for providing the information on the state of natural resources.

Natural Resource Accounting Cell will compile the data relating to natural resources within an accounting framework. Natural Resource Accounting (NRA) is an accounting system that deals with stocks and stock changes of natural assets, comprising biota (produced or wild), subsoil assets (proved reserves), water and land with their aquatic and terrestrial ecosystems. NRAs may involve both physical units and monetary values. The resources in question may include both those which contribute to marketable forms of production as well as non-commercial or environmental resources such as air, water and biological life. NRAs are regarded as a means of creating linkages between the environment and the economy.

2. The headquarter of the Natural Resource Accounting (NRA) Cell shall be at Chandigarh.

3. **Role and Functions of the Committee:**

- To determine the methodology for preparation of Asset Accounts on mineral and energy resources in State.
- Initiation and preparation of disclosure statement on revenues and expenditure related to NRA.
- Preparation of National Asset Accounts on mineral and energy resources.
- Preparation of Asset Account in respect of other three resources namely water, land and forest resources.
- Preparation of supply and use table in physical and monetary terms showing flow of natural resources inputs, products and residuals.
- Preparation of the economic accounts highlighting depletion adjusted economic aggregates.
- Preparation of functional accounts recording transactions and other information about economic activities undertaken for environmental purposes.

4. Meeting :

The committee shall meet once in two months or earlier if required.






