
**Subject:- Re-appropriation Orders for the year 2022-23.**

As per the provisions contained in Para 14.5 (v) of Punjab Budget Manual (as adopted by Haryana Government) which provides that Re-appropriation Orders are not permissible after closing of the financial year. The delayed submission of Re-appropriation Orders cause delay in finalization of Appropriation Accounts and the Accountant General (A&E), Haryana is unable to adhere to due date fixed by the office of Comptroller & Auditor General of India. The Re-appropriation Orders issued after 31<sup>st</sup> March, 2023 or received after 15<sup>th</sup> April, 2023 would not be incorporated by the Accountant General (A&E), Haryana.

3. It is, therefore, requested to furnish the details of Re-appropriation Orders for the year 2022-23 by 10<sup>th</sup> April, 2023 positively, so that all Re-appropriation Orders for the year 2022-23 prior to 31<sup>st</sup> March, 2023 are submitted to the office of Accountant General (A&E), Haryana.
