Further, earlier orders of promotion as Accounts Officer under PwD Act, issued vide Endst. No.16/6/2022-4FA dated 30.09.2022 is herby modified to the extent of dates mentioned against concerned Accounts Officer.

- 2. The aforementioned promotion is given subject to the following conditions:-
- (i) Above promotions are subject to contents regarding integrity etc. in their awaited ACRs.
- (ii) Their services shall be governed as per respective service rule.
- (iii) In case the claim belonging to disability certificate is found false and fabricated at any stage later on, concerned will be reverted without any notice and without any prejudice to such further disciplinary action be initiated under the provision of the Indian Panel Code for production of such false/fabricated documents.
- (iii) The date of roster/promotion can be changed /amended/altered, if required on the basis of any legitimate claim of some other persons of SAS/Treasury Cadre received later on.
- (iv) The candidate would not claim any arrear of pay on account of his/her notional promotion and only notional benefits of pay fixation will be granted. He/she would be granted actual benefit of pay fixation from actual date of joining to promotional post.
- (v) After promotion, seniority of these officers will be determined as per instructions/rules issued or notified by the Government of Haryana from time to time.
- (vi) The candidate would have no claim of seniority over those who are otherwise senior to him /her but his/her case could not have been got considered for promotion due to one reason or the other.
- (vii) He/she will not claim seniority above his/her senior on the basis of this promotion and he/she would be reverted to the feeder post without serving any notice if any senior to him/her is /are found fit or entitled for promotion at later stage in the event of decision in the seniority position made by the department.
- (viii) The instructions dated 25.03.2022 are challenged in CWP No. 9975 of 2022 titled as Vijay Kumar Jindal and others Vs. State of Haryana & others. The promotion orders would be liable to be modified in view of any amendment made in instructions dated 25.03.2022 & 01.07.2022, received from the Govt. at a later stage.
- 3. The posting order as Senior Accounts Officers in respect of officers at Sr. No. 5, 6, 7, 8, 9 and 10, will be issued shortly. However, they would submit their joining report initially at their place of posting or at Head Quarter, while discharging the duty as Accounts Officers only, till they are assigned a new place of posting, with a copy of the said joining to Finance Department (FA Branch).
- 4. Notice issued by the Government vide Endst. No.16/6/2022-4FA dated 30.09.2022 to Sh. Ajit Singh, Accounts Officer is hereby withdrawn.
- 5. Case for grant of benefit of promotion as Chief Accounts Officer under PwD Act, to the officers (Persons with Disability) at Sr. No. 1, 2, 4, 6, and 7, who have not been actually promoted on the post of Chief Accounts Officer, will be considered after DPC meeting.
