4. Promotion of all the above Section Officers shall be subject to remarks in their current ACR for the period 2022-23. In case of any adverse remark in this ACR is received, their promotion orders will be reviewed without any notice.

5. Promotion of Sr. No. 16 i.e. Smt. Manisha Ahlawat is further subject to remarks in her pending ACRs i.e. ACRs for the period 1.4.2014 to 7.9.2014 and 17.12.15 to 31.3.16. In case of any adverse remark in her pending ACRs is received at any later stage, her promotion orders shall be reviewed without any notice.
