Subject : Departmental Financial (Haryana Amendment) Rules, 2023.

This is with reference to FD's earlier instructions No.11/25/2023-1FR/2478 dated 13.02.2023 whereby copy of Haryana Government Gazette pertaining to Departmental Financial (Haryana Amendment) Rules, 2023 dated 03.02.2023 was circulated alongwith certain other relevant points of actions.

With regard to Sr.No.6 of Departmental Financial (Haryana Amendment) Rules, 2023 dated 03.02.2023 related to acceptance of tenders for the execution of all types of works by contract, it has been decided by the Government that Board of Directors or Governing Body or Executive Committee/Council (whichever is the highest authority) of the Boards and Corporations will first approve cases for more than Rs.10.00 Crores for each work thereafter the same shall be placed before concerned competent authority (High Powered Works Committee) as defined in said notification dated 03.02.2023 read with letter dated 13.02.2023.

It has been further decided by the Government that the recommendation of the Executive Head/Head of Department of the Boards/Corporations and that of the Board of Directors/Governing Body of Boards/Corporations would be made available when the matter is taken up for consideration in the High Powered Works Committee. This may be brought to the notice of all concerned for strict compliance.
