Hon'ble Punjab and Haryana (Pb. & Hr.) High Court vide its order dated **31.08.2010** had decided the **CWP No. 2371 of 2010** titled as Harbans Lal vs State of Punjab and others. The operative part of above said Court Order dated **31.08.2010** reads as under:

"In view of the above, the writ petition is allowed. Accordingly respondents are directed to treat the whole period of work charge service as qualified service for pension because accordingly to clarification issued on 30.5.2008 (Annexure P-3), the new defined Contributory Pension Scheme would be applicable to all those employees who have been working prior to 1.1.2004 but have been regularized thereafter. Let his pension and arrears be calculated and paid to him expeditiously, preferably within a period of three months from the date of receipt of copy of this order."

No doubt this case relates to Government of Punjab, whereas employee(s) of Haryana Government have filed CWP No. 13067 of 2021 titled as Ramesh Chander vs State of Haryana and others in the Hon'ble Pb. & Hr. High Court for claiming the similar benefits.

Hon'ble Pb. & Hr. High Court vide its interim order dated **12.05.2023** in above said CMs, has desired to intimate as to whether any benefit has been granted by Government of Haryana to its employee(s) on the basis of Court Order dated 31.08.2010 in CWP No. **2371 of 2010** titled as Harbans Lal vs State of Punjab and others or not.
