Subject:- Payment of Dearness Allowance to Haryana Government employees, who are drawing their pay as per 5th Pay Structure w.e.f. 1st January, 2023.

The Governor of Haryana is pleased to enhance the Dearness Allowance (DA) payable to Haryana Government employees, who are drawing their pay as per 5th pay structure, from existing rate of **396% to 412%** of the pre-revised basic pay **with effect from 1st January, 2023.**

2. Enhanced DA shall be paid with the pay of July, 2023 and arrear for the months of January, 2023 to June, 2023 shall be paid in the month of August, 2023. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
