Subject: Submission of Fresh Pension Cases through Online Diary Management System (ODMS) -- **Family ID (Parivar Pehchan Patra) - Clarification thereof.**

Sir/Madam,

Kindly refer to this Department's memo No. 2/2/2019-1Pension (FD) dated **19.07.2023** vide which it was decided by the State Government that the pensioner(s) must fill-up Family ID (FID) **in the pension paper(s)** (including online entry of Family ID (FID) while entering pensioner's data) **mandatorily** w.e.f. **01st August, 2023**. Principal Accountant General (A&E), Haryana would also mention the FID in the e-PPO for all fresh Pension cases processed through Online Diary Management System (ODMS).

A large number of queries has been received in the Finance Department as to whether the said instructions is also applicable in respect of pension cases for which pension papers had already been submitted by the Government employee(s) to the Principal Accountant General (A&E), Haryana and PPO(s) is yet to be issued.

In this regards, it is clarified that the above said instructions dated **19.07.2023 are not applicable**, in respect of the pension case(s) for which pension papers had already been submitted by the Government employee(s) to the Principal Accountant General (A&E), Haryana upto **31.07.2023**.

You are requested to bring the above instructions to the notice of employees (prospective pensioners) working in your Department for compliance.
