No. 11/91/2021-3FR/16101.— In exercise of the powers conferred under the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Civil Services (General) Rules, 2016, namely:-

- (1) These rules may be called the Haryana Civil Services (General) Amendment Rules, 2023.  
(2) These rules shall be deemed to have come into force from the 1st September, 2021.
- In the Haryana Civil Services (General) Rules, 2016, in rule 143, sub-rule (2) shall be omitted.
