Subject:- Payment of Dearness Allowance to Haryana Government employees, who are drawing their pay as per 5th Pay Structure w.e.f. 1st July, 2023.

The Governor of Haryana is pleased to enhance the Dearness Allowance (DA) payable to Haryana Government employees, who are drawing their pay as per 5th pay structure, from existing rate of **412% to 427%** of the basic pay **with effect from 1st July, 2023.**

2. Enhanced DA shall be paid with the pay of December, 2023 and arrear for the months of July, 2023 to November, 2023 shall be paid in the month of January, 2024. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.




