

Subject:- Re-appropriation Orders for the year 2023-24.


Kindly refer to the subject cited above.

2. As per the provisions contained in Para 14.5 (v) of Punjab Budget Manual (as adopted by Haryana Government) which provides that Re-appropriation Orders are not permissible after closing of the financial year. The delayed submission of Re-appropriation Orders causes delay in finalization of Appropriation Accounts and the Accountant General (A&E), Haryana is unable to adhere to due date fixed by the office of Comptroller & Auditor General of India. The Re-appropriation Orders issued after 31st March, 2024 or received after 15th April, 2024 would not be incorporated by the Accountant General (A&E), Haryana.
3. It is, therefore, requested to furnish the details of Re-appropriation Orders for the year 2023-24 by 5th April, 2024 positively, so that all Re-appropriation Orders for the year 2023-24 prior to 31st March, 2024 may be submitted to the office of Principal Accountant General (A&E), Haryana.
4. These instructions may be brought to the notice of all concerned for strict compliance.


