Subject: Implementation of Judgments passed by different Courts.

Sir/Madam,

I am directed to invite your attention to the instructions issued by this Department vide letter No.3/6/2004-2Pension dated 25.07.2005 and letter No.3/1/2012-2Pension(FD) dated 15.01.2013 on the subject cited above.

2. It has been pointed out by the Principal Accountant General (A&E) Haryana that despite crystal clear ibid instructions of Government of Haryana, the Departments are still forwarding the pension cases to PAG, Haryana office without obtaining the prior approval of the Finance Department, in compliance to Court judgment which contrary to existing provisions of Punjab Civil Services Rules, Vol-II/Haryana Civil Services (Pension) Rules, 2016. This results unnecessary shuttling of pension cases, even in some cases contempt petition is filed by the plaintiff/petitioner.

3. It is, therefore, requested to follow up the instructions dated 25.07.2005 and 15.01.2013 in letter & spirit.

4. These instructions may be brought to the notice of all concerned for strict compliance.
