- 2. In this context, it has already been informed by the Finance Department in para-8 of FD's earlier instructions No.24/02/2019-1FR/32201 dated 11.05.2020 that Hon'ble Punjab and Haryana High Court has dismissed CWP No.1426 of 2020 Mahabir Singh & Others Vs. State of Haryana & anothers vide judgement dated 20.02.2020 and it was requested that concerned departments shall mention this judgement in preliminary submissions of reply in pending CWPs and try to get the same disposed of accordingly. The same were reiterated vide FD's instructions No.124/02/2019-1FR(FD)/21619 dated 12.10.2023

4. Now, Hon'ble High Court has also passed following judgement on 06.03.2024 in CWP No.1505 of 1998 – Tara Chand Verma & others Vs. State of Haryana & others:-

"The petition has been filed, inter alia, seeking a writ of certiorari quashing paragraphs no.3 and 4 of the government order dated 20.3.1974, regarding grant of additional Dearness Allowance (DA) to Haryana Government employees. It permits deduction of excess amount of DA paid to the employees in a phased manner.

- 2. Learned State counsel contends that the issue at hands stands decided by the Supreme Court in State of Haryana and another v. O.P. Sharma and others, 1993 Suppl. (2) SCC 386, holding that recovery of excess amount of DA paid to the employees in a phased manner in terms of impugned order dated 20.3.1974, cannot be termed arbitrary or unreasonable. Therefore, the relief claimed cannot be granted to the petitioners.
- 3. Since the impugned order has already been upheld by the Supreme Court, nothing survives for adjudication.
- 4. Dismissed.
- 5. Pending miscellaneous application(s), if any, stands disposed of accordingly."
- In view of above, it is hereby again advised to go through various instructions of the Finance Department and judgements, referred to above, and get the pending CWPs/LPAs dismissed from the Hon'ble High Court in consultation with departmental officers (SAS & Attorney cadre) as well as Shri R.D. Sharma, DAG O/o Advocate General, Haryana (who is well conversant with the matter in question). Such cases may be got specifically marked to Shri R.D. Sharma, DAG.
- 6. In case reply has already been filed then, an additional affidavit stating all these facts may be placed on record of the Hon'ble High Court for just adjudication of the pending case.
