The Governor of Haryana is pleased to enhance the Dearness Relief (DR) payable to Haryana Government pensioners and family pensioners, who are drawing their pension/family pension as per 5th pension structure, from existing rate of 427% to 443% of the basic pension/family pension with effect from 1st January, 2024.

- 2. Enhanced DR shall be paid with the pension/family pension of July, 2024 and arrears for the months of January, 2024 to June, 2024 shall be paid in the month of August, 2024. The payment on account of Dearness Relief involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
