संख्या 11/75/2023—1एफ.आर./22823.— भारत के संविधान के अनुच्छेद 309 के परन्तुक के अधीन प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, हरियाणा सिविल सेवा (यात्रा भत्ता) नियम, 2016 को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात्:—

- 1. (1) ये नियम हरियाणा सिविल सेवा (यात्रा भत्ता) संशोधन नियम, 2024 कहे जा सकते हैं।
 - (2) ये नियम राजपत्र में इनके प्रकाशन की तिथि से लागू होंगे।
- 2. हरियाणा सिविल सेवा (यात्रा भत्ता) नियम, 2016 में, नियम 33 में, उप—िनयम (2) में, खण्ड (iii) के स्थान पर, निम्नलिखित खण्ड प्रतिस्थापित किया जाएगा, अर्थात्ः—
 - "(iii) पुलिस कार्मिक एक मास में बीस दिन तक, उनकी तैनाती के स्थान को विचार किए बिना।"।

No. 11/75/2023-1FR/22823.— In exercise of the powers conferred under the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Civil Services (Travelling Allowance) Rules, 2016, namely:-

- 1. (1) These rules may be called the Haryana Civil Services (Travelling Allowance) Amendment Rules, 2024.
 - (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. In the Haryana Civil Services (Travelling Allowance) Rules, 2016, in rule 33, in sub-rule (2), for clause (iii), the following clause shall be substituted, namely:-
 - "(iii) Police personnel upto twenty days in a month, irrespective of their place of posting.".
