2. Four (4) posts of Accounts Officer have been kept reserved for Persons with Disabilities (PwD) as per notification No. 22/59/2020-1HR-III, dated 11.07.2023 and one (1) post have been kept reserved for Scheduled Castes category to the extent of 20% as per notification No. 22/56/2023-5HR-III, dated 07.10.2023.

3. Promotion of above Section Officers to the post of Accounts Officer shall be subject to the following conditions:-

- a) Under the provision of Rule 10 of the Haryana State Accounts (Group B) Service Rules, 2013, they will be on probation for a period of one year.
 - b) Their posting orders will be issued separately.
 - c) They shall submit their joining as Accounts Officer at their present place of posting alongwith a copy to Finance Department (FA branch). Till allocation of posting station as Accounts Officer, they will continue to work on their present post/ place of posting and perform same duties, as assigned to them. Their pay as Accounts Officer will be fixed after their posting as such, till then; they will continue to draw salary against the post of Section Officer at their present place of posting.
4. Promotion of all the above Section Officers shall be subject to condition that nothing gets recorded against their integrity in awaited ACRs for the period 2022-23 & 2023-24.
5. Their promotion shall be subject to the final outcome of CWP No. 24608 of 2023 titled as Kamaljeet Singh and others V/s State of Haryana and others.
6. These orders are issued in compliance of Hon'ble High Court orders dated 23.05.2024 passed in COCP No. 1803-2024 titled Kuldeep Singh and others V/s

Anurag Rastogi, IAS & Anothers filed in CWP No. 28727 of 2023 titled Kuldeep Singh and others V/s State of Haryana and others.
