Subject: Adoption of **e-NPS** facility for PRAN generation under NPS for Government employees and employees of State Autonomous Bodies (SABs).

Sir/ Madam,

I am directed to invite your kind attention to the Finance Department's Notification No. 1/1/2004-1Pension dated 18.08.2008 wherein the Defined Contributory Pension Scheme (Haryana New Pension Scheme, 2008) for the State Government employees appointed on or after 01.01.2006 was notified and further relevant instructions /guidelines issued vide letter No. 1/1/2004-1Pension dated 04.12.2008 and others from time to time. Instructions were also issued vide letter No. 2/47/2007-1Pension(FD) dated 22.06.2020, 27.01.2022, 20.10.2022 and 16.11.2022, letter No. 2/32/2012-1Pension(FD) dated 17/21.02.2022 & 10.10.2022 and 05.12.2022 and letter No. 1/1/2004-1Pension dated 08.05.2023 on the subject cited above.

State Government had already adopted the **online PRAN Generation Module (OPGM)** under Defined Contributory Pension Scheme, in respect of Government employees of all Departments of State of Haryana w.e.f. 01.06.2020 vide Memo No. 2/47/2007-1Pension dated 22.06.2020 and also for employees of State Autonomous Bodies / Boards/Corporations, vide Memo No. 2/47/2007-1Pension(FD) dated 16.11.2022.

The CRA- Protean eGov Technologies Limited, Mumbai (earlier NSDL) has informed that eNPS facility is now available to Government Sector for PRAN generation under National Pension System (NPS) alongwith its following salient features:-

Sr. No.	Particulars	e-NPS PRAN Generation (Additional Facility)
1	Timeline for PRAN Generation	Instantly upon request authorization.
2	Physical Paperwork	Paperless- AADHAAR eSign based.
3	Form filling / data Entry	Only subscriber (only verification by DDO & Authorization by DTO).
4.	PRAN Card	ePRAN only
5.	PRAN Generation Charge	Rs.18/- per PRAN
6.	Service Enabling	Optional upon intimation to CRA (in addition to default service and / or OPGM).

After due consideration, it has been decided by the State Government to **adopt 'e-NPS facility** for Haryana Government employees as well as employees of SABs/ Boards/Corporations/ Universities/ Government Aided Institutions etc. of Haryana Government, **as an additional facility for PRAN generation, under NPS in addition to existing OPGM procedure.**

The above said decision is applicable with immediate effect.
