Subject:-

Course of action regarding filing of Reply/RA/LPA/SLP on the issue of notional increment falling due on 1st July on completion of 6 months and more or 12 months of service, for the purpose of pension etc.

Sir/Madam,

I have been directed to draw your kind attention towards Finance Department's following instructions:-

- I. Memo No. 6/183/2018-4PR dated 04.01.2024.
- II. Memo No. 6/44/2024-4PR dated 23.07.2024
- III. Memo No. 6/44/2024-4PR dated 13.08.2024
- IV. Memo No. 6/44/2024-4PR dated 03.09.2024
- 2. Further, the State Government has also filed SLPs in the Hon'ble Apex Court and the Hon'ble Court has passed the following orders:-
 - (i) Orders dated 02.09.2024 in SLP(C) No. 19158 of 2024—The State of Haryana & Ors. Vs. Sant Lal Aggarwal
 - 1. Issue notice on the application(s) seeking condonation of delay as well as on the Special Leave Petitions.
 - 2. Dasti, in addition, is permitted.
 - 3. In the meanwhile, the High Court shall not proceed with the contempt proceedings, if any, filed by the respondent(s) herein.
 - (ii) Orders dated 09.09.2024 in SLP(Civil) Diary No. 37859 of 2024—The State of Haryana & Ors. Vs. Subhash Chander Sharma
 - 1. Issue notice on the application seeking condonation of delay as well as on the Special Leave Petition.
 - 2. In the meantime, operation of the impugned order dated 15.04.2024 in CWP No. 28644/2020 passed by the High Court of Punjab & Haryana at Chandigarh shall remain stayed.
- 3. Further, in the similar matter, the Union of India has filed Miscellaneous Application vide Diary No. 2400/2024 in SLP (C) No. 4722 of 2021--Union of India and another Vs. M. Siddaraj. The same was listed for hearing on 06.09.2024 and the Hon'ble Apex Court has passed the following orders:-

"It is stated that the Review Petition in Diary No. 36418/2024 filed by the Union of India is pending.

The issue raised in the present applications requires consideration, insofar as the date of applicability of the judgment dated 11.04.2023 in civil Appeal No. 2471/2023, titled "Director

(Admn. and HR) KPTCL and others v. C.P. Mundinamani and others", to third parties is concerned.

We are informed that a large number of fresh writ petitions have been filed.

To prevent any further litigation and confusion by of an interim order we direct that:-

- (a) The judgment dated 11.04.2023 will be given effect to in case of third parties from the date of the judgment, that is, the pension by taking into account one increment will be payable on and after 01.05.2023. Enhanced pension for the period prior to 31.04.2023 will not be paid.
- (b) For persons who have filed writ petitions and succeeded, the directions given in the said judgment will operate as res judicata, and accordingly, an enhanced pension by taking one increment would have to be paid.
- (c) The direction in (b) will not apply, where the judgment has not attained finality, and cases where an appeal has been preferred, or if filed, is entertained by the appellate court.
- (d) In case any retired employee has filed any application for intervention/impleadment in Civil Appeal No. 3933/2023 or any other writ petition and a beneficial order has been passed, the enhanced pension by including one increment will be payable from the month in which the application for intervention/impleadment was filed.

This interim order will continue till further orders of this court. However, no person who has already received an enhanced pension including arrears, will be affected by the directions in (a), (c) and (d).

Re-list in the week commencing 04.11.2024."
