No. 2/14/2018-1Pension(FD).— In exercise of the powers conferred under the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Civil Service (Judicial Branch) and the Haryana Superior Judicial Service (Revised Pension) Part-II Rules, 2024 namely:-

- 1. (1) These rules may be called the Haryana Civil Service (Judicial Branch) and the Haryana Superior Judicial Service (Revised Pension) Part II (Amendment) Rules, 2024.
 - (2) They shall be deemed to have come into force on the 1st day of January, 2024.
- 2. In the Haryana Civil Service (Judicial Branch) and the Haryana Superior Judicial Service (Revised Pension) Part-II Rules, 2024, in rule 11, for sub-rule (1), the following sub-rule shall be substituted, namely:-
 - "(1) The maximum limit of death-cum-retirement gratuity shall be Rs. 25.00 Lakh (Twenty Five Lakh Rupees)."
