Subject: Filing of SLP in relation to judgment dated 19.07.2024 (**Issue no. 2**) passed in Bunch Matter titled - CWP No. - 17310 of 2015- Shamsheer Singh and others V/S State of Haryana (**Stay granted by Hon'ble Supreme Court of India**)

Sir/Madam,

I am directed to say that Hon'ble Punjab and Haryana High Court vide its Order dated 19.07.2024 passed in Bunch Matter titled - CWP No. - 17310 of 2015- Shamsheer Singh and others v/s State of Haryana, has stuck down Rule 8(3) of Haryana Civil Services (Revised Pension) Part-II Rules 2009 regarding reducing of qualifying service.

2. On the basis of advise tendered by the Advocate General, Haryana, School and Elementary Education Department filed SLP in Hon'ble Supreme Court of India against the Judgment dated 19.07.2024 (Issue No.2) of the Full Bench of Hon'ble Punjab and Haryana High Court in CWP No. 17310-2015 (**Diary No. 50360/2024**).

3. Hon'ble Supreme Court of India in the SLP (Diary No. 50360/2024-State of Haryana v/s Shamsheer Singh and Diary no. 2454/ 2025, State of Haryana v/s. Dilbag Singh) filed against the Order dated 19-07-2024 (in CWP No. 17310-2015) (issue no. 2) has **granted Stay on 20.01.2025** (stay of contempt petition).(copy enclosed)


4. It has been observed that number of COCPs are pending in Hon'ble Punjab and Haryana High Court on this issue. Therefore, the Hon'ble Contempt Court, in case of pending COCP against the Department, may be apprised of the **Stay granted** by the Hon'ble Supreme Court of India on **20.01.2025** in main case titled as State of Haryana v/s Shamsheer Singh (CWP No. 17310-2015) and connected case (State of Haryana v/s. Dilbag Singh). **Further the contempt petition may be got dismissed by getting Rule discharged in the interest of justice from the Hon'ble Contempt Court.**

5. It is therefore requested to take action accordingly under intimation to the Finance Department.
