Subject: Filing of SLP in relation to judgment dated 19.07.2024 (**Issue no. 2**) passed in Bunch Matter titled - CWP No. - 17310 of 2015- Shamsher Singh and others V/S State of Haryana.

Sir/Madam,

I am directed to say that Hon'ble Punjab and Haryana High Court vide its Order dated 19.07.2024 passed in Bunch Matter titled - CWP No. - 17310 of 2015- Shamsher Singh and others v/s State of Haryana, has struck down Rule 8(3) of Haryana Civil Services (Revised Pension) Part-II Rules 2009 regarding reducing of qualifying service.

2. On the basis of advise tendered by the Advocate General, Haryana. School and Elementary Education Department filed SLP in Hon'ble Supreme Court of India against the Judgment dated 19.07.2024 (Issue No.2) of the Full Bench of Hon'ble Punjab and Haryana High Court in CWP No. 17310-2015 (**Diary No. 50360/2024**).

3. Hon'ble Supreme Court of India in the SLP (Diary No. 50360/2024-State of Haryana v/s Shamsher Singh and Diary no. 2454/ 2025, State of Haryana v/s. Dilbag Singh) filed against the Order dated 19-07-2024 (in CWP No. 17310-2015) (issue no. 2) has **granted Stay** of contempt petition **on 20.01.2025**.

4. It is requested to **file the SLP, in consultation with Advocate General Haryana, in related CWPs of their Department** against the Hon'ble High Court order dated 19-07-2024 passed in Bunch Matter Lead Case CWP 17310 of 2015 on issue no. 2 in a time bound manner. If any document required for filing the SLP the same may be obtained from the School and Elementary Education Department as the lead case CWP No. 17310 of 2015 related to their department wherein SLP has also been filed by the Department.

5. It is therefore requested to take action accordingly under intimation to the Finance Department.
