**Subject:** Monitoring of New Pension Scheme (NPS)- Regarding release of NPS contributions & missing credits after final withdrawal processed by CRA.

Sir/Madam,

I am directed to invite your kind attention to the Finance Department's letter No. 2/47/2007-1 Pension dated **23.07.2012** and dated **05.11.2012** wherein the detail guidelines for withdrawal of pension corpus under NPS on superannuation and on death as well as other than superannuation was issued.


Further the State Government had already issued instructions for release of NPS contributions & missing credits after final withdrawal processed by CRA vide memo No. 2/8/2016-1Pension dated **20-04-2017**.

Now as reported by the Director, Treasuries and Accounts Department, Haryana, there are many instances wherein last 3 months Government Contribution has not been disbursed to the subscribers as per Government instructions. Director, Treasuries & Accounts has requested to reconsider the facts and grant one time exemption so that Treasury Officers may disburse Government Contribution to such subscribers in compliance to above Government instructions dated **20-04-2017**.

After due consideration and to resolve the issue once for all, it has been decided by the State Government to grant one time exemption to disburse Government contribution for the last three (3) months prior the date of superannuation (whether employee's share is deducted or not, as the case may be) to the subscribers who have already been retired between May 2015 to December 2022, in reference to the provisions of memo No. 2/8/2016-1Pension dated 20-04-2017. The due amount of Government contribution should be verified by the concerned DDO of the Department.


You are requested to bring the above instruction to the notice of employees of your Department and ensure compliance.
