Sir,

I am directed to invite your kind attention on the subject cited above and to state that it has been come to the notice of the Finance Department that the pay level and type of posts of Sports Cadre in the Universities of the State are not uniform in all the Universities. For which, the employees of Academic Universities have approached the Hon'ble Court by filing CWPs as cited in the subject. In most of the Universities, these posts are non-teaching posts.

2. Now, after careful consideration and to maintain uniformity in the pay level of these posts, Government has decided that the pay structure of the Sports Cadre in all the Universities including KUK/Colleges is hereby re-determined in the following manner:-

| Designation | Pay Level | Remarks |
|---|-----------|--------------------|
| Coach/Sports Coach /Game Organizer/Athlete Coach | Level-6 | Non-Teaching Posts |
| Assistant Sports Officer | Level-7 | Non-Teaching Posts |
| Sports Officer | Level-9 | Non-Teaching Posts |
| Assistant Director (Sports) | Level-10 | Non-Teaching Posts |
| Director (Sports) | Level-11 | Non-Teaching Posts |

3. Further, wherever the Pay Level of these posts in any of the University is higher than that of mentioned above, the same may be reviewed accordingly. However, pay of the employee occupying this post (if any) may be protected in the above said Pay Level.
