No. 11/49/2024-3FR/29660.— In exercise of the powers conferred under the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Civil Services (General Provident Fund) Rules, 2016, namely:-

1. (1) These rules may be called the Haryana Civil Services (General Provident Fund) (Amendment) Rules, 2025.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. In the Haryana Civil Services (General Provident Fund) Rules, 2016, in rule 9, in Form P.F. No. 1 after serial number 4 and entries thereof and, the following serial numbers and entries thereof and shall be inserted, namely:-
