संख्या 05/60/2021—1एफ.आर./14664.— भारत के संविधान के अनुच्छेद 309 के परन्तुक के अधीन प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, हरियाणा सिविल सेवा (सरकारी कर्मचारी भत्ते) नियम, 2016 को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात्:—

- 1. (1) ये नियम हरियाणा सिविल सेवा (सरकारी कर्मचारी भत्ते) संशोधन नियम, 2025 कहे जा सकते हैं।
 - (2) ये राजपत्र में इनके प्रकाशन की तिथि से लागू होंगे।
- 2. हरियाणा सिविल सेवा (सरकारी कर्मचारी भत्ते) नियम, 2016 में, नियम 16 के स्थान पर, निम्नलिखित नियम प्रतिस्थापित किया जाएगा, अर्थात:—

"16 सेवा के दौरान मृत्यु होने के मामले में मकान किराया भत्ता.— सेवा के दौरान मृत्यु होने के मामले में, मृतक सरकारी कर्मचारी का परिवार निम्नलिखित के लिए हकदार होगा—

- (क) मृत्यु से ठीक पूर्व प्राप्त दर पर दो वर्ष की अवधि के लिए मकान किराया भत्ता: या
- (ख) सामान्य अनुज्ञप्ति फीस के भुगतान पर दो वर्ष के लिए सरकारी आवास बनाए रखना।

टिप्पण.— जहाँ मृतक सरकारी कर्मचारी के परिवार द्वारा अपनी स्वेच्छा से सरकारी आवास दो वर्ष से पूर्व सुपर्द कर दिया जाता है, तो शेष अवधि के लिए कोई मकान किराया भत्ता अनुज्ञेय नहीं होगा।"।

No. 05/60/2021-1FR/14664.— In exercise of the powers conferred under the proviso to article 309 of the Constitution of India, the Governor of Haryana hereby makes the following rules further to amend the Haryana Civil Services (Allowances to Government Employees) Rules, 2016, namely:-

- 1. (1) These rules may be called the Haryana Civil Services (Allowances to Government Employees) (Amendment) Rules, 2025.
 - (2) They shall come into force from the date of their publication in the Official Gazette.
- 2. In the Haryana Civil Services (Allowances to Government Employees) Rules, 2016, for rule 16, the following rule shall be substituted, namely:-
- "16 House rent allowance in case of death while in service. In case of death while in service, the family of deceased Government employee shall be entitled to-
 - (a) house rent allowance for a period of two year at the rate drawn immediately before the death; or
 - (b) retain Government accommodation for two year on payment of normal licence fee.
 - Note.— Where Government accommodation is surrendered by the family of deceased Government employee on their own accord before two year, no house rent allowance shall be admissible for the remaining period.".
