Subject: Issue of family pension in respect of Widow daughter/Divorced daughter/Disabled children.

Sir/Madam,

I am directed to invite your attention towards Rule 8(10)(B) of Haryana Civil Services(Pension) Rules, 2016 which defines the family for the purpose of family pension. Note-3 given below Rule- 8(10)(B) of ibid rule provides that son/daughter includes children legally adopted under the Hindu Law or personal law of the Government employee residing with and wholly dependent upon his/her parent but does not include step children.

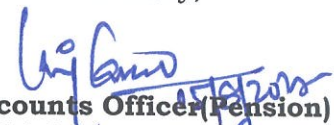
2. It has been pointed out by the Principal Accountant General (A&E) Haryana that Pension Sanctioning Authorities of Haryana Government Departments are not following the provision of aforesaid rule while forwarding the family pension cases of Widow/Divorced daughter/Disabled children. Their office is facing difficulty in assessing the dependency of the claimant/eligible family member on his/her parents.

3. It is therefore requested to direct the Pension Sanctioning Authorities under your control as under:

- i. To comply the Haryana Civil Services (Pension) Rules, 2016 in letter and spirit while recommending the family pension cases in favour of Widow/Divorced daughter and Disabled children residing on different addresses, to PAG(A&E), Haryana office. It should be ensured that the cases are in accordance with the provision of Note-3 below Rule-8(10)(B) of HCS (Pension) Rules, 2016.
- ii. The family pension cases should be forwarded to PAG Haryana office with clear recommendation with commencement date and tenability period of family pension rather than just forwarding the pension papers.

4. These instructions may be brought to the notice of all concerned for strict compliance. These instructions may also be downloaded from website of Finance Department www.finhry.gov.in.
