ORDER

Subject:- Payment of Dearness Allowance to Haryana State Government employees, who are drawing their pay in pre-revised pay structure (5th Pay Commission) w.e.f. 1st July, 2025.

The Governor of Haryana is pleased to enhance the Dearness Allowance (DA) payable to Haryana Government employees, who are drawing their pay as per 5th Pay Commission, from existing rate of **466% to 474%** of the basic pay **with effect from 1st July, 2025.**

2. Enhanced DA shall be paid with the pay of November, 2025 and arrears for the months of July, 2025 to October, 2025 shall be paid in the month of December, 2025. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
