2. The above promotion is subject to the following conditions:-

- i) All the above officers shall continue the work at the same place where they are presently posted till their posting orders issued as Senior Accounts Officer.
- ii) The above Accounts Officers have been promoted against the vacancies of the quota of Treasury Officers with the condition that as and when any Treasury Officer is eligible/fulfils all the conditions as per the provisions of Haryana State Accounts Services (Group B) Rules, 2013, the junior most Senior Accounts Officer will be reverted back to the post of Accounts Officer without any notice and the concerned eligible Treasury Officers will be promoted in their place, if no vacancy of Senior Accounts Officers will be available at that time.
- iii) The officers will remain on probation for a period of one year that is extendable as per rules.

- iv) They shall have no right of seniority over and above their seniors who are facing departmental proceedings and who will later on exonerated after the final decision of said proceeding and found fit for promotion.
- v) These promotions are subject to condition that nothing gets recorded against integrity in their awaited ACRs.
- vi) If any officer under disability quota is found eligible then the junior most Senior Accounts Officer will be reverted to his/her feeder post i.e. Accounts Officer without any notice.
- vii) Promotion of all above officers will be subject to condition of final outcome of Sh. Jarnail Singh's case pending in the Hon'ble Supreme Court of India.
- viii) This promotion is subject to the adoption of creamy layer policy for SC category employees in the future.
- ix) Their posting order will be issued later on. However, they would submit their Joining report initially at their place of posting or at Head Quarter, while discharging the duty as Accounts Officers only, till they are assigned a new place of posting with a copy of the said joining to Finance Department (FA Branch).
