Subject:- Extension of benefits of 'Retirement Gratuity and Death Gratuity' to the State Government employees covered by Unified Pension Scheme (UPS).

I am directed to invite your kind attention to the Finance, Department's Notification No. 1/23/2024-IPension (FD) dated 02.07.2025 regarding introduction of the Unified Pension Scheme (UPS) **w.e.f. 01.08.2025** in respect of State Government employees who are recruited in service on or after 01.01.2006 and covered under the NPS.

Accordingly, it is clarified that the State Government employees covered by Unified Pension Scheme (UPS) shall be eligible for benefit of 'Retirement gratuity and Death gratuity' under the provisions of this Department OM No. 2/6/2010-1 Pension dated 19.01.2017 regarding NPS.


