Subject: Issue of change in Date of Birth in case of Family Pensioners.

Please refer on the subject noted above.

2. It has been pointed out by Principal Accountant General, (A&E) Haryana that:-

- (i) the departments are not sending the Family Pension cases of the deceased Government employee as per the rules.
- (ii) even the date of birth of the family pensioners has not been indicated in a proper manner and indicate the different date of birth in the family pension papers.

Due to non-completion of family pension cases, it is very difficult for them to finalization the family pension case.

3. In relation to proof of date of birth, Finance Department had already issued Office Memorandum No. 2/14/2009-1Pension dated 20.10.2009 wherein detail of the documents (duly attested by a Gazetted Officer) is mentioned as under:

- (i) Pan Card
- (ii) Matriculation Certificate (containing the information regarding date of birth)
- (iii) Passport
- (iv) CGHS Card
- (v) Driving license (if it contains date of birth)

4. Now after due consideration, State Government has decided that the family pension cases of the family pensioner of the deceased of the Government employee may be sent to Principal Accountant General, (A&E) Haryana invariably as per provisions contained in Office Memorandum No. 2/14/2009-1Pension dated 20.10.2009 in a time bound manner.

5. You are, therefore, requested to direct the concerned officers under your control for strict compliance.
