2. Terms & Condition are as under:-

- (i) If any adverse remarks are found during the period for which ACR has not been received, the officer will be reverted to the post of Assistant Superintendent Treasury without any notice.
- (ii) They will have to qualify the departmental exam in the prescribed number of chances as laid down in the Haryana Finance Department, Treasuries (Group B) Service Rules, 1980 applicable to them.
- (iii) Under the provisions of Rule-10 of Haryana Finance Department, Treasuries (Group-B) Service Rules, 1980, they will be on probation for a period of one year.
