Subject: - Implementation of e-Voucher (Paperless) under SNA SPARSH.

Please refer to Finance Department Instruction No. 28/33/2022-5B&C(T&A) dated 21.8.2024, vide which SNA SPARSH was adopted in the State for release of funds under CSS Scheme. Thereafter, vide instruction no.28/33/2022-5B&C(T&A) dated 01.05.2026 State Government has decided to implement Digital Signature Certificate(DSC) for all Implementing Agencies. **State Government now has decided to discontinue the submission of Physical voucher for salary/ honorarium (in the first go) of contractual and regular employees in the Cyber Treasury/Treasuries w.e.f. 11th May 2026 under SNA SPARSH.**


2 From now onward, Implementing Agencies and Drawing and Disbursing Officer under SNA SPARSH will not submit physical vouchers related to salary/honorarium payments of contractual and regular employees under SNA SPARSH related to Object Code-01(salary regular employee), 69(contractual), 87(Honorarium), and 38(GIA for salary). After successful submission of digital voucher (e-Voucher) with digital signature, token No. will be generated automatically. Cyber Treasury / Treasury officers will send digitally signed pay order (EPS) to the DDO concerned for online verification.

3 It is further conveyed that if any DDO is drawing salary/remuneration of any beneficiaries from other "head" than above mentioned "object head" then suitable budgetary provision shall be made in consultation of Finance Department. **It is further clarified that the entire responsibility regarding correctness of any payment and eligibility of any beneficiary/Vendor under SNA SPARSH shall rests with concerned implementing agency and their controlling officer/DDO.** Further, the guidelines issued by PAG(A&E) Haryana from time to time regarding e-Voucher shall be observed in letter and spirit.


