Subject: Disbursal of Loans/Advances to Government Employees-(Discontinuation of Loaning Arrangement) by the State Government, regarding.

The State Government has decided to withdraw the Notification No. 2/2/2004-WM(3) dated 04th November, 2016, regarding loaning arrangement with Punjab National Bank (PNB) and further decided to resume disbursement of loans/advances to eligible Government employees from the State Budget under Major Head 7610 - Loans to Government servants etc. w.e.f. 01st of June, 2026.

2. **With the implementation of this decision, the loans/advances to the eligible State Government employees from 01st of June 2026 shall be granted from the State budget in accordance with the Notification no. 2/2/2004-3WM dated 02nd April, 2026 (enclosed herewith for information and necessary action) as amended from time to time.**

3. Above decision shall be implemented as per the following details:

Part A: Fresh disbursal of Advances to employees by the State Government

- a) Disbursement of loans/ advances by State Government directly from State Budget under Major Head 7610 - Loans to Government servants etc. shall begin w.e.f. 01st of June, 2026, as per system followed prior to implementation of ibid notification dated 04th November, 2016.
- b) Finance Department will provide funds at the disposal of all the Heads of Department for issuing necessary sanctions to dispense fresh loans directly to eligible employees w.e.f. 01st of June, 2026. The same would be made available under the different schemes to the respective Budget Controlling Authorities in accordance with instructions bearing No. 2/2/2004-WM(3) dated 02nd May, 2012.

Part B: Stoppage of loaning arrangement through PNB

- a) Fresh loans through PNB will be stopped w.e.f. 01st of June, 2026. The MoUs/ Agreements with PNB shall cease to exist qua fresh loans from that date.
- b) All existing loans (including those created till 31st of May, 2026) with PNB shall continue to be repaid by the employees as per

existing arrangements with PNB till the completion of reconciliation exercise.

You are requested to bring these instructions to the knowledge of all concerned for strict compliance and to take necessary action accordingly. The above instructions can also be downloaded from the website of Finance Department, Haryana i.e. www.finhry.gov.in.
