The Governor of Haryana is pleased to promote following Assistant Treasury Officers to the post of Treasury Officer in the functional Pay Matrix level-9 as per 7th Pay commission under the provisions of Haryana Finance Department, Treasuries (Group B) Service Rules, 1980 with the terms and conditions as mentioned at point No. 2.

1.	Sh. Satish Kumar Yadav (Sub-Treasury-Bawal)	Subject to the condition that nothing gets recorded against his integrity in the awaited ACR for the year of 2025-26.
2.	Sh. Narendar Kumar, (Sub-Treasury- Ambala Cantt.)	Subject to the condition that nothing gets recorded against his integrity in the awaited ACR for the year of 2025-26.
3.	Sh. Ashwani Sharma (Cyber-Treasury- Panchkula)	Subject to the condition that nothing gets recorded against his integrity in the awaited ACR for the year of 2025-26.

2. Terms & Condition are as under:

- i. They will be on probation for a period of one year.
- ii. If any adverse remarks are found in the pending ACR of the Officer concerned he will be reverted to the post of Assistant Treasury Officer without any notice.
- iii. Promotion of all above Officers will be subject to condition of final outcome of Sh. Jarnail Singh's case pending in the Hon'ble Supreme Court of India.
- iv. This promotion is subject to the adoption of creamy layer policy for SC Category employees in the future.

3. One post has been kept reserved for the candidate belonging to SC Category in light of Haryana Government instruction No. 22/56/2023-5HR-III dated 07.10.2023.

4. Consequent upon promotion to the post of Treasury Officer, they are posted as under:

Any divergence from the same will be viewed seriously and will make the officer liable for disciplinary proceedings. Any extension in time for joining the new place of posting will only be with prior approval of the Administrative Secretary, Finance and it will be the responsibility of the officer to seek such extension timely, if required.

6. Further, the request of Smt. Poonam Rani, Assistant Treasury Officer, Sub-Treasury Shahbad to forego promotion is accepted as per Haryana Civil Service (ACP) Rule 2016 for a period of one year. Therefore, the pay of the said officer shall be re-fixed as per Rule-14 of HCS (ACP) Rule 2016.
