Subject: Provisional appointment to the post of Treasury Officer/Assistant Treasury Officer in the Treasuries and Accounts Department, Haryana.



On the recommendation of Secretary, Haryana Public Service Commission, Panchkula, received vide No. Exam 3/2020/120-42 dated 27.03.2026, the Governor of Haryana is pleased to issue provisional appointment to you on the post of Treasury Officer/Assistant Treasury officer (Group-B) in the Treasuries and Accounts Department, Haryana purely on Temporary basis in FPL-9/ FPL-7 as per recommendations of 7th Pay

Commission, 2016 plus usual allowances as are sanctioned by the Haryana Government from time to time from the date of your joining on duty.

2. This appointment is subject to the conditions mentioned below:

- i. Appointment will be provisional subject to the conditions i.e verification of the Character and Antecedent, as mentioned in Govt. letter no. 52/08/2018-2HR-III dated 11.10.2024.
- ii. That in case of any certificate/document submitted by you is found fake/bogus, the appointment will be cancelled automatically without any notice/intimation.
- iii. You must submit the medical fitness certificate at the time of joining issued by the Medical Board of Post Graduate Institute of Medical Science(PGIMS), Rohtak or the Director General Health Services, Sector-6, Panchkula.
- iv. You will remain on probation for a period of two years and will be governed by the Haryana Finance Department Treasuries(Group-B) Rules, 1980.
- v. If the work and conduct during the period of probation, in the opinion of appointing authority is not found satisfactory or you fail to pass the departmental examination as prescribed in the service rule, the Appointing Authority can remove the candidates from service. The total period of Probation including extension, if any, shall not exceed 3 years. On completion of probation period, the appointing authority may confirm the candidates if a permanent vacancy exist.
- vi. You will have to complete 02 months training successfully given by Accounts Training Institute Haryana, Panchkula as prescribed in Sub Rule 12 of the Service Rules, before being placed in charge of Treasury.
- vii. After completion of Training period you will be required to take the departmental examination which you will have to pass within the probation period only. The departmental examination will be held in June and December of each year. There will be 03 papers of departmental examination as are prescribed by the Government for this class of Service. The candidates securing 40% marks in each paper and 45% in the aggregate will be deemed to have passed the examination. The syllabus of examination will be as per notification of the Haryana Government dated 21.07.1995 or prescribed by the Government from time to time.
- viii. You will have to serve at any place within jurisdiction of Haryana State Government in India.
- ix. You will have to join the post on your own expenses.
- x. In case, You are married, you should have only one living spouse and if you have more than one living spouse, you should justify the circumstances in this regard.
- xi. If at any stage you desired to resign the post, you will be required to give one-month clear notice or you shall have to deposit one-month salary including allowances or the salary for the period by which the notice falls short of one month in lieu of one-month notice. Such a notice will also be given to you by the Government, in case it is proposed to terminate the services.
- xii. Your services will be governed by as per Haryana New Pension Scheme, 2006.

3. If the conditions mentioned above are acceptable to you please report yourself for duty at the Principal, Accounts Training Institute, Haryana, Sinchai Bhawan, Sector -5, Panchkula within 15 days positively after getting medical fitness from Medical Board of Post Graduate Institute of Medical Science(PGIMS), Rohtak or the Director General Health Services, Sector-6, Panchkula and send a copy of Joining Report to the Government as well as Director, Treasuries and Accounts Department, Haryana, Chandigarh.
