I am directed to refer to the subject noted above and to say that the matter regarding charging of interest on various loans and advances given to the Government employees including IAS officers has been considered and it has been decided to charge interest in the 2nd Quarter of 2026-27 (i.e 1st July, 2026 to 30th September, 2026) on various loans and advances sanctioned as given below:-

2. In case of mis-utilization of any loan, penal interest @10% per annum will be charged from the applicant over and above normal rate of interest.

3. It has also been decided to fix the rate of interest at 7.10% per annum on deposits in the General Provident Fund (GPF) and other similar funds w.e.f. 01.07.2026 to 30.09.2026.
