Subject: Instructions regarding tendering methodology and adoption of Quality and Cost Based Selection (QCBS) methodology.

Sir,

I am directed to inform that in order to ensure greater transparency, uniformity, accountability and efficiency in the public procurement process, it has been decided to rationalize the adoption of the **Quality and Cost Based Selection (QCBS)** methodology for all procurement processes initiated after the date of issuance of this Order with immediate effect as under:

1. The Quality and Cost Based Selection (QCBS) methodology shall be adopted only in exceptional cases involving the selection of consultants for highly specialized or technical assignments where such methodology is considered indispensable and justified.
2. Every proposal seeking adoption of the Quality and Cost Based Selection (QCBS) methodology shall be submitted by the concerned Department/implementing agency through the Administrative Department for obtaining the **prior approval of the Hon'ble Chief Minister** before issuance of the Notice Inviting Tender (NIT).
3. No Department or implementing agency shall issue any tender under the QCBS methodology without obtaining the aforesaid prior approval.

The above instructions shall come into force with immediate effect and shall be applicable to all Departments of the State Government, Boards, Corporations, Statutory Bodies, Authorities, Universities, Societies receiving Government funding, and all other agencies undertaking public works or procurement out of Government funds.
