





#### Visit pay.ecourts.gov.in

Visit pay.ecourts.gov.in from your web browser to pay for Court.

#### Select payment option

Select payment option from menu like Court fee, Judicial Deposit, Fine, Penalty.





Enter CNR NO. / Case No. (Mandatory field) Enter CNR or other case details (State, District/Court Complex) to view party

#### Enter party name

Enter party name for new case or select party name from dropdown for existing case.

#### Authenticate OTP

Enter mobile number & click on Generate OTP. You will receive OTP on your phone. Verify OTP to proceed.
