3.Photos Kiosk Some of the most common types of photo kiosks are instant print stations, digital order stations, movie ticketing, DVD vending, building directory and public transport ticketing kiosks.

- **1. Directory of Information kiosk** This type of interactive kiosk is utilized purely for information. Typically, they are installed in large areas with a high density of people (like malls or theme parks) to provide useful details about the area.
- **2. Product Promotion Kiosk** Product promotion kiosks are often used in retail to provide information and offer a chance for potential customers to take advantage of promotions.
- **3. Self-Service Kiosk** These kiosks are widely used as they help businesses and customers save time and money. Functions include paying bills, filling out application forms and other easy tasks that can be done without requiring staff assistance. Some of the most common self-service kiosks are self-ticketing at movie houses, self-ordering at restaurants, and self-check in at the airport.
