

- 1) Information of RTI
- 2) Non Judicial Stamp of Rs. 50/
- 3) Copy of official Identity.

In this case, application ID not generated instantly but after some time.


Payment of Offline RTI info cost

RTI Appeal- If applicant is not satisfied with the information given by RTI section, applicant can apply for Appeal against concerning RTI,




