## 1 Introduction

JustIS mobile app is provided to Judicial officers to monitor pendency and disposal at finger tips.

JustIS 2.0 version of the app has facilities for the **Principal District Judge** for monitoring pendency and disposal of entire district. Additional features like "Briefcase" to view the disposal of cases during previous postings are provided.

#### **Key Features**

- Available on Android and iOS
- Pendency and disposal monitoring for entire area under jurisdiction
- Facility to add and save notes related to a case
- Option to mark cases as important
- Provision to view dashboards and important cases of earlier postings
- Cases marked as important are highlighted in cause list for easy identification
- Reports available in tabular and graphical formats

1. Login into the eCourts app store (<u>https://justis.ecourts.gov.in/appstore/</u>) using JO code and OTP authentication.

# 6 Judge Dashboard

#### Note: The facility is available only for Principal District Judge.

Facility is provided to view judge-wise dashboard. Any district judge in the jurisdiction area can be selected. Following information is available for the selected judge-

- Alerts, Pending and Disposed statistics for the district of the selected judge
- Cause list
- Calendar
- Imp Cases

Procedure to select judge

- Click on Dashboard tab; a pop-up will appear to select judge. Judge can be selected by name or by establishment.
- Select Judge name, designation and click on OK.
- If Establishment is selected, respective judges are available for selection
