

#### Record Room Case Tracking System Ver. 1.0: An inperiphery application (Record Room Case house Tracking System) was developed by the e-Courts technical team to track the status of the case records after disposal when the case record is sent to Record Room. Through this application the transactions (physical existence, case record called for by higher Court etc.) is being digitally maintained in the Record Room once the case record is disposed of and sent to Record Room.

VMS (Vacancy Monitoring System) Ver. 1.0 Application Software for monitoring vacancy of Judicial Officers and staff members for High Court as well as District Courts has been developed by the in-house Technical Team.



PESJO (Performance Evaluation System for the Judicial Officer) Ver. 1.0 Application Software has been developed to monitor the judicial performance/disposal of the Judicial Officers by the High Court.



Periphery Reporting Module: Application for multiple report generation from CIS Application Software through periphery module has been developed.




- Initiative has been taken for creation of Virtual Benches for Virtual hearing of Court Proceedings in two Districts.


