In exercise of powers conferred upon him u/s 12-A(2) of Jharkhand State Universities Act,2000 ( as amended up-to-date) and in consultation with the State Government, Hon'ble Governor-cum-Chancellor of the Universities of Jharkhand has been pleased to determine the terms and conditions of Financial Advisor of the Universities of Jharkhand as hereunder.

TERMS AND CONDITIONS OF SERVICE OF FINANCIAL ADVISOR OF THE  
UNIVERSITIES OF JHARKHAND

Financial Advisor, a whole time officer of the University shall be appointed by the Chancellor either on deputation or by re-employment from amongst the officers of the Indian Audit and Accounts Department or from any other Accounts Services of Govt. of India.

The terms and conditions of services of Financial Advisor are as follows:-

1-AGE-

The Financial Advisor shall hold office for a period of three years with effect from the date he assumes charge. The maximum age limit for appointment of Financial Advisor shall be 62 Years.

2 REGULATION OF PAY AND ALLOWANCE:-

(A) For a Financial Advisor appointed by Chancellor on deputation basis, the terms and conditions of deputation will be as that of Central Govt. employees and governed under Appendix 5 of FRSR Part I General Rules, as modified by office Memorandum of the Dept.of Personnel and Training, Govt. of India bearing no.6/8/2009-Edt (Pay II) dt.17/6/2010.

(B) (i) Re-employed pensioner shall be allowed to draw pay only in the prescribed scales of pay for the posts in which they are re-employed. No protection of the scales of pay of the posts held by them prior to retirement shall be given.

(ii) A Government servant on re-employment should draw the initial pay of the post unless Government sanction advance increments under rule 83 of the Jharkhand Service Code provided always that the sum total of pay plus pension does not exceed the substantive pay last drawn by him before discharge. Where the sum exceeds the last substantive pay only so much of the pension may be allowed to be drawn as not to make the total of pension plus the initial pay of the post exceed the last drawn substantive pay.

(iii) Drawal of increments- Once the initial pay of a re-employed pensioner has been fixed in the manner indicated above, he may be allowed to draw normal increments in the time-scale of the post to which he is appointed as if the pay had been fixed at the minimum or the higher stage, as the case may be (i.e., before an adjustment on account of pension and pension equivalent of other forms of retirement benefits is made), provided that the pay and gross pension/pension equivalent of other retirement benefits taken together do not at any time exceed the substantive pay last drawn.

(iv) Allowances:- The drawal of various allowances like dearness allowance, H.R.A. etc and other benefits based on pay shall be regulated with reference to the pay that is fixed on re-employment.

(v) Leave and leave salary-In the case of persons re-employed after retirement, the provisions contained in the Central Civil Services (Leave) Rules, 1972, shall apply.

(vi) Gratuity/Death/Retirement Gratuity- Re-employed officers shall not be eligible for any gratuity/death/retirement gratuity for the period of re-employment except in those cases covered in Rules 18 and 19 of the Central Civil Services (Pension) Rules, 1972.

(vii) Sumptuary Allowance-The Financial Advisors would not be entitled to Sumptuary Allowance.

(viii) Medical Facilities- Entitled to the facilities as provided in the Universities.

(ix) T.A. & DA:- Traveling allowances and Daily allowance on tour shall be paid as applicable to University servants drawing basic pay.

(x) Residential accommodation:- He will be entitled to residential accommodation according to the rules of the University in which he is holding the post.

No free house or free car will be allowed, nor any conveyance be provided at University expense, unless such benefits are normally attached as a condition of service to the post which he is holding.

झारखण्ड राज्य विश्वविद्यालय अधिनियम, 2000 (अंगीकृत एवं यथा संशोधित) की धारा 12 A में राज्य के विश्वविद्यालयों के वित्तीय सलाहकार का पद का उल्लेख है जिसमें अंकित है कि :-

“वित्तीय सलाहकार एक पूर्णकालिक अधिकारी होगा। उसकी नियुक्ति या तो प्रतिनियुक्ति या भारतीय लेखा परीक्षण सेवा या भारत सरकार की कोई अन्य लेखा सेवा के अधिकारी या झारखंड वित्त सेवा के सहायक आयुक्त के पद से नीचे नहीं के अधिकारी का पुनः नियोजन कुलाधिपति करेंगे। जबतक ऐसे किसी अधिकारी की नियुक्ति नहीं हो जाती है, तबतक पदधारी वित्तीय सलाहकार के रूप में कार्य कर सकेंगे।”

02. विभागीय ज्ञापांक 5/वि01-06/ 2009-1188, दिनांक 20.11.2010 जिसके द्वारा झारखंड राज्य के विश्वविद्यालयों/अंगीभूत महाविद्यालयों में कार्यरत शिक्षकों एवं पदाधिकारियों को UGC पैकेज के अनुरूप छठा पुनरीक्षित वेतनमान एवं सेवाशर्त की स्वीकृति प्रदान की गई है। वित्त परामर्शी के पद का वेतनमान की स्वीकृति प्रदान नहीं की गई है। यह मामला राज्य सरकार के समक्ष विचाराधीन था।

03. बिहार सरकार, मानव संसाधन विकास विभाग के संकल्प सं0-2693, दिनांक 27.08.2010 की कंडिका 2 (a) एवं उसकी अनुसूची-1 (ख) के क्रम सं0-1 में वित्त परामर्शी के पद हेतु छठा पुनरीक्षित वेतनमान अंतर्गत 37400-67000 ग्रेड पे - 10000/- रुपये निर्धारित किया गया है। जिसमें स्पष्ट है कि वित्त परामर्शी के पद का वेतनमान देने पर बिहार सरकार द्वारा वर्ष 2010 में ही मंत्रिपरिषद की सहमति से निर्णय लिया जा चुका है।






