Circular

NBER, RCI has constituted an Admission Committee to finalize the admission guidelines, application form and schedule for admission to diploma level courses **through Centralized Online Admission Process (COAP): 2021 for the academic session 2021-22.**


2. Admission Committee in its Meeting held on 10th August, 2021 recommended that the following certificate & diploma level courses to be exempted from Centralized Online Admission Process with an objective to strengthen the enrolment of these courses.

Certificate Course in Care Giving	01
Certificate Course in Rehabilitation Therapy	01
Diploma in Community Based Rehabilitation	02
Diploma in Prosthetics & Orthotics	02
Diploma in Rehabilitation Therapy	2 ½
Diploma in Hearing Aid Repair and Ear Mould Technology	01
Diploma in Hearing Language & Speech	01
Diploma in Early Childhood Special Education (Hearing Impairment)	01
Diploma in Early Childhood Special Education (Intellectual Disability)	01
Diploma in Vocational Rehabilitation (Intellectual Disability)	01
Diploma in Computer Education (Visual Impairment)	01

3. Accordingly, Training Institutions are advised to take direct admissions to these courses for the current academic session i.e. 2021-22, as per the following guidelines:

- Admission process to be commenced from 31st Aug., -30th Sept., 2021.
- Admission Committee comprising of following members to be constituted by the respective Training Institutes:
 - Head of the organization/institute : Chairperson
 - Principal or its nominee of any nearby Govt. School : Member
 - Head of any other RCI approved Training Institutes : Member
 - One representative belongs to SC/ST : Member
- Admission to be given only to that candidate who fulfils the prescribed eligibility criteria as mentioned in the syllabi of the concerned course.
- Reservation Policy will be applicable for SC/ST/OBC/PwD/EWS category as per the Policy of the concerned State Govt. /Union Territory.
- Last date for submission of final list of admitted students alongwith the recommendations of the admission committee is **30th October, 2021** through e-mail only at nberrci-depwd@gov.in . List received after the due date shall not be considered, under any circumstances.
- No request for extension of last date for admission and relaxation in admission criteria shall be considered under any circumstances.
- Admission should be made only for the approved intake and in no case, it should exceed the approved numbers of seats.

- viii. It is the sole responsibility of the Head of the Training Institute to ensure the transparency in admission process at training institute. Any litigation in the admission process should be dealt by the respective Training Institute only.
- ix. Once admission done, no request for change of course and change of institution shall be entertained.
- x. Cost of application form for General and OBC candidates is Rs. 500/- and Rs. 350/- for SC, ST and EWS candidates. PwD candidates are exempted from application fee.
- xi. In case, extension of approval is regretted by the Council, admission taken by the institute stands cancelled and Training Institute will have to transfer admitted students to the nearby training institution under intimation to the Council.
- xii. Deviation in any of the above instructions and guidelines will lead to disciplinary action as per rules.
