MINUTES OF THE THIRD MEETING OF THE TASK FORCE CONSTITUTED FOR CONDUCTING ALL INDIA SURVEY ON HIGHER EDUCATION

The third meeting of the Task Force constituted for conducting All India Survey on Higher Education was held on 21st February, 2011 in National University of Education & Planning (NUEPA) New Delhi. The list of participants is annexed.

At the outset, Shri Sunil Kumar, Chairman, welcomed all the members of the Task Force and emphasized to complete the survey at the earliest.

MHRD made a presentation on the action plan for conducting the pilot testing as well as main survey. Data Capture Formats (DCF) to be used for conducting the survey was also discussed by the members of Task Force. Minor changes were suggested in the DCF.

NUEPA made a presentation on the Tentative Time Frame, cost estimates and series of steps for conduct of the survey.

Special invitee from Institute of International Education made a presentation on the DCF used in USA for collecting the data on higher education.

NIC made a presentation on the prototype of the software to be developed for conducting the main survey.

The Task Force has taken the following decisions:

2. NUEPA will prepare the proposal consisting of tentative cost estimates and time schedule for conducting the main survey as discussed in the meeting by 23rd February,

2011 for approval from IFD, MHRD. The cost estimate will include the following three components separately

- Pilot Testing
- Software Development
- Main Survey

- 4. Pilot testing will be conducted by the officials of NUEPA, MHRD and UGC. For this purpose officials of Higher & Technical Education Department of Government of Delhi & Gujarat and Andhra Pradesh State Higher Education Council. These officials will be the resource persons for conduct of the main survey work. Honorarium will be paid to these officials.

- 6. Report on the findings of the pilot testing will be prepared by NUEPA in collaboration with UGC/MHRD and will be presented before the Task Force to decide further course of action.
- 7. To capture the historical data available in the records for 2010-11, the date of reference for the survey will be September, 30, 2010. However, the data so collected will be updated for 2011-12 with reference date as 30th September 2011 to capture the latest data by revisiting the institutions.
- 8. A Project Approval Board (PAB) will be constituted under the chairmanship of Prof R. Govinda, Vice Chancellor, NUEPA with Dr. Vijay P.Goel, DDG, MHRD as member. If required other members may be nominated by the chairman.
