The Governor of Haryana is further pleased to say that a person shall not be qualified for appointment as a Commissioner unless he/she has:

1. Essential Qualification:- Graduate from a recognized university.
2. Desirable:- Recognized degree/diploma in Social Work/Law/Management/Human Rights/Rehabilitation/Education of disabled persons.
3. Experience:- Should have at least 25 years experience of which at least 3 years experience in the recent past should have been in the field of empowerment of persons with disabilities.
4. Upper age limit is 65 years.  
This supersedes all previous decisions on the subject.
