**NOTIFICATION**

Notification under the section-3 & 4 of Haryana Aadhaar

(Targeted Delivery of Financial and other subsidies, benefits and services) Act, 2017

No.796-SW(4)-2017. The use of Aadhaar as identifier for delivery of services/benefits/subsidies simplifies the Government delivery processes, brings in transparency and efficiency, and enable beneficiaries to get their entitlement directly to them in a convenient and hassle free manner, Aadhaar obviates the need for producing multiple documents to prove one's identity. The provisions of the State Aadhaar Act and Regulations under the Act have come into effect from 23<sup>rd</sup> March 2017 in State of Haryana for the schemes funded out of consolidated fund of State and notifications to this effect have been published in the Official Gazette.

The following services of Social Justice and Empowerment Department, Haryana involved expenditure incurred from consolidated funds of State:-

1. Old Age Samman Allowance/ Indira Gandhi National Old Age Pension Scheme
2. Widow & Destitute women Pension/Indira Gandhi National Widow Pension Scheme
3. Disability pension scheme/Indira Gandhi National Disability Pension Scheme
4. Financial Assistance to Destitute Children
5. Ladli Social Security allowance
6. Financial Assistance to Non-School going Disabled Children
7. Financial Assistance to Kashmiri Migrant Families Scheme
8. Allowance to Dwarf
9. Allowance to Eunuchs

Accordingly, Social Justice and Empowerment Department, Haryana in exercise of its powers under Section-3 & 4 of Haryana Aadhaar (Targeted Delivery of Financial and other subsidies, benefits and services) Act, 2017 hereby notifies the following for all the above services:-

- a. Individual desirous of availing above services/benefits/subsidies for above services are hereby required to furnish proof of possession of Aadhaar or undergo Aadhaar authentication or in case of Individual to whom no Aadhaar number has been assigned, such individuals shall be offered alternate and viable of identification for delivery of the subsidy, benefit or service subject to the production of the following documents:
  - i) Voter identity card
  - ii) Driving License
  - iii) Matriculation Certification with photo identification
  - iv) Ration Card
  - v) Haryana resident certificate

- b. An individual desirous of getting any of the above services and not yet enrolled for Aadhaar is hereby required to make application for Aadhaar enrolment, in case she or he is entitled to obtain Aadhaar as per provision of section 3 of the said Central Aadhaar Act and such individual may visit any Aadhaar Enrolment Centres (list available at [www.uidai.gov.in](http://www.uidai.gov.in)) to get enrolled for Aadhaar.
